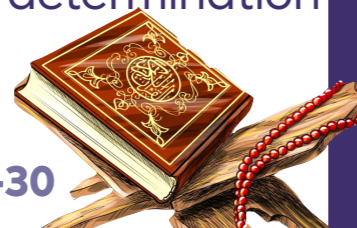

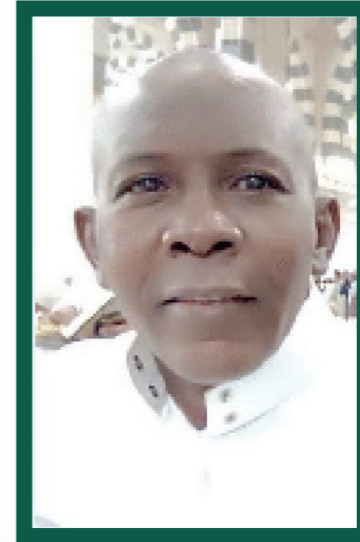
instrumental in determining the fare. This inclusive approach ensures that the interests of all stakeholders are taken into account, ultimately benefiting Nigerian pilgrims.

## Nigeria's Hajj Preparations Gain Momentum at Saudi Conference

The National Hajj Commission of Nigeria (NAHCON) has announced the Hajj fare for the 2025 pilgrimage, with varying costs for different zones. Intending pilgrims from Southern States will pay N8.7 million, while those from Borno and Adamawa Zone will pay N8.3 million. Pilgrims from the Northern Zone will pay N8.4 million.

The dynamics of Hajj fare in Nigeria are influenced by several factors, including the cost of services which includes transportation, ticket fare, accommodation, feeding, transport with the Kingdom and other services. In 2024, the Hajj fare ranged from N6.8 million for those who benefited from the Federal Government's N90 billion Hajj intervention to N8.5 million for those who did not benefit from the federal government largesse.

One would have expected that without the largesse coming this year, hajj fare would have skyrocketed to N10million or above but the efforts of Prof Usman, it still remained comparatively better than what we had last year.

NAHCON through Hajia Fatima Sanda Usara, while announcing the fare recently said: the leadership of NAHCON, in collaboration with representative of the Presidency, Malam Ameen Amshi, Special Assistant to the President, Special Duties, did their best to maintain the hajj fare within the same range as previously charged.

" This modest effort on the fare was reached after extensive consultations to ensure inclusivity in this important decision-making process.

Compared to the 2024 Hajj fare, the 2025 rates without the usual subsidy is about the same or less, depending on the zone.

The announcement of the 2025 Hajj fare has been welcomed by stakeholders, who appreciate the efforts of NAHCON to maintain the fare within a reasonable range. The commission's collaboration with the Presidency, the Forum of Executive Secretaries of State Pilgrims Welfare Boards, Agencies and Commissions,

and other stakeholders has been instrumental in determining the fare.

Prospective pilgrims are advised to take note of the timelines and Saudi guidelines, and to make early payments and timely registrations to avoid last-minute inconveniences. With the announcement of the 2025 Hajj fare, Nigerian pilgrims can now begin to make preparations for the upcoming pilgrimage.

This proactive approach is expected to alleviate concerns among prospective pilgrims, especially those who benefited from the Federal Government's N90 billion Hajj intervention last year, where fares were significantly lower.

## 'Tent-A' in Mina: NAHCON Chairman seeks State Govs' support

**T**HE Chairman/CEO of the National Hajj Commission of Nigeria (NAHCON), Prof. Abdullahi Saleh Usman, recently visited the Katsina State Governor, Malam Dikko Radda where he requested for support of the Northern Governors on issue of Tent-A in Mina. During the visit, the Chairman

emphasized the pressing need for collaboration to enhance the Hajj experience for Nigerian pilgrims. The meeting, held at the Katsina State Government Lodge in FCT, Abuja, provided an opportunity to address significant concerns, particularly around accommodation arrangements in Mina.

Reflecting on the challenges faced during last year's Hajj, Prof. Usman expressed his commitment to ensuring that such issues do not recur. He specifically requested Governor Radda's assistance in urging other state governments to submit lists of officials who prefer Tent-A accommodations. In addition to discussing accommodation, the NAHCON Chairman and the governor explored strategies to improve various aspects of the 2025 Hajj, including airlift arrangements, Hajj fares, medical care, and Basic Travel Allowance (BTA). Prof. Usman also sought the governor's support in advocating for the Federal Government to reconsider issuing pilgrims' BTA through ATM credit cards during Hajj to enhance financial accessibility for pilgrims.

Governor Radda responded positively, assuring Prof. Usman that he would present these crucial requests at the upcoming meeting of the Northern Governors' Forum. He expressed his commitment to rallying support from religious leaders and state officials to enhance public awareness and participation in Hajj matters.

## Jigawa secures accommodation for 1,518 intending pilgrims

**T**HE Jigawa State Pilgrims Welfare Board says it has secured a befitting accommodation for its intending pilgrims ahead of the 2025 Hajj exercise in Saudi Arabia.

This is contained in a statement by the Spokesman to the board, Malam Habibu Yusuf, on Monday in Dutse.

He said the board has successfully secured a befitting hotel accommodation, a walking distance of about 800 meters to the Holy Mosque in Makkah.

"This achievement is a testament to the board's commitment of ensuring a seamless and enriching Hajj experience for Jigawa state pilgrims," he said.

The statement quoted the Director-General of the board, Alhaji



Ahmad Labbo, as urging the intending pilgrims to ensure prompt deposit of the Hajj fare.

Labbo underscored the importance of early payment to facilitate proper planning of logistics for the pilgrimage.

The board had fixed Jan. 30, registration deadline of intending pilgrims for the 2025 Hajj exercise.

This is in line with directives of the National Hajj Commission of Nigeria (NAHCON) for the state pilgrims welfare boards to remit all collections by Feb. 1.

NAHCON has allocated 1,518 seats to the state for 2025 Hajj, while the board had directed intending pilgrims from the state to pay N8.4 million Hajj fare.

we yet to make full payment to complete it before the deadline set by the National Hajj Commission of Nigeria (NAHCON),

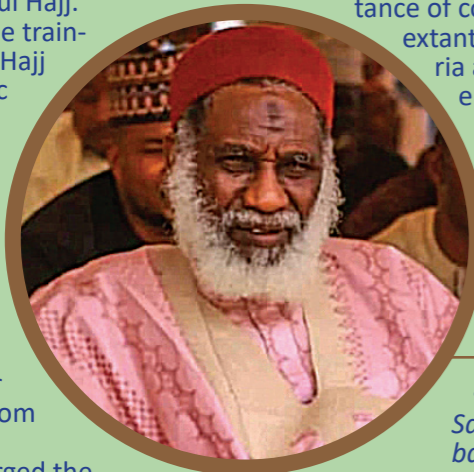
"The commission has allocated over 6,000 Hajj seats to Kaduna State for 2025," he said.

## Nahcon Secures Mashair Space For 52,000 Intending Pilgrims Ahead Of Deadline

**T**HE national hajj commission of nigeria (nahcon) has successfully paid for 26,287 pilgrims' spaces in mashair and reserved another 26,000 to be fully secured by the end of business tomorrow 13th february 2025 pending awaited remittances. The 26,287 fully secured spaces cover the pilgrims' deposits so far received. 52,000 Intending pilgrims are projected to participate in the 2025 hajj.

This proactive move to reserve space in mashair, led by nahcon chairman, professor abdullahi saleh usman, ensures compliance with the 14th february deadline laid by saudi ministry of hajj and umrah (mohu) for finalizing contract agreements by hajj participating countries before the closure of the nusuk masar contracts' portal.

As part of this effort, professor usman had signed an agreement on friday, 17th january 2025, at nahcon's ummul judd office in makkah. The signing followed wide consultations with key stakeholders, particularly the forum of state chairmen, board members and representative of the presidency who were part of the delegation. It would be recalled that professor usman acknowledged the collaborative role of malam idris almakura, alhaji faruku

yaro aliyu, malam abubakar salihu from the states forum and malam ameen amshi, representative of the presidency in the screening and selection process. Hence, after the successful engagement of the service provider early in the year, and to prevent any last-minute setbacks, the nahcon chairman professor usman sought and received approval from vice president sen. Kashim shettima to travel to makkah and finalize this critical contract—an essential requirement for uploading visas scheduled to commence on the 19th of february.

Professor usman expressed profound appreciation to the vice president for his support, confidence, and non-interference in the commission's operations, which have enabled swift and decisive action in preparing the grounds for a smooth hajj process for 2025 nigerian pilgrims. According to the nahcon chairman, the vice president's quick response to request to travel to saudi arabia to resolve any bottlenecks has paid off well with the reservation now put to rest. Professor usman urged intending pilgrims to follow nahcon news outlets for updates and to remain calm as all efforts have been put in place to ensure that they experience a convenient and hitch-free hajj this year.

The National Hajj Commission of Nigeria (NAHCON) has intensified efforts to make hajj more affordable for Nigerian pilgrims while also fostering interfaith harmony and cooperation.

In two separate engagements held at the Commission's headquarters in Abuja, NAHCON Chairman, Professor Abdullahi Saleh Usman, met with the Sub-Technical Committee on Hajj Fare Packages and later hosted the Chairman of the National Christian Pilgrims' Commission (NCPC), Bishop Stephen Adegbite, on a courtesy visit.

### Efforts to Reduce Hajj Cost

The Sub-Technical Committee on Hajj Fare Packages, a sub-committee of the Committee on Muslim Pilgrimage of the National House of Representatives, paid a fact-finding visit to the NAHCON Chairman to explore strategies for reducing the cost of Hajj for Nigerian pilgrims.

The delegation was led by Hon. Mohammed Garba Chiroma and included Hon. Hassan Bala Abubakar III, Hon. Aminu Jamo, Hon. Abubakar Abdul Buba, Hon. Abdulkarim Hussaini Ahmad, and Hon. Ja'afar A. Magaji. The committee engaged in discussions on airfare, accommodation, feeding, and other service charges with the aim of making the pilgrimage more affordable.

Hon. Chiroma commended NAHCON's commitment to addressing the financial burden on intending pilgrims and pledged the committee's support in negotiating better rates and advocating for necessary government interventions.

In response, Professor Usman assured the committee of NAHCON's full cooperation and revealed ongoing engagements with service providers, airlines, and Saudi authorities to secure cost-effective services for Nigerian pilgrims.

He further disclosed that NAHCON had formally written to the Presidency seeking waivers for domestic aviation charges imposed by the Nigerian Civil Aviation Authority (NCAA), the Federal Airports Authority of Nigeria (FAAN), the National Emergency Management Agency (NEMA), and other regulatory bodies. He called on the committee to support NAHCON's request, emphasizing that these waivers would significantly help in reducing the overall cost of Hajj.

Additionally, Professor Usman announced that NAHCON had initiated the process of requesting a waiver from the Central Bank of Nigeria (CBN) concerning the 2% CBN charge on foreign exchange transactions. He emphasized that securing this waiver would further lower Hajj

expenses for Nigerian pilgrims.

The Sub-Technical Committee also called for a meeting with the approved airlines for the 2025 Hajj to further discuss ways to reduce airfare in the interest of Nigerian pilgrims. The committee stressed the importance of collaborating with airline operators to ensure cost efficiency without compromising service quality.

The committee also requested detailed cost breakdowns and service agreements records/documents from key stakeholders involved in Hajj logistics to facilitate an informed assessment of areas where costs can be cut.

The Sub-Technical Committee is expected to submit its findings and recommendations in due course to the House Committee on Muslim Pilgrimage which will contribute to final decisions on reducing the 2025 Hajj fare.

### Strengthening Interfaith Harmony

In a separate engagement, NAHCON Chairman, Professor Abdullahi Saleh Usman, welcomed the Chairman of the National Christian Pilgrims' Commission (NCPC), Bishop Stephen Adegbite, who paid a courtesy visit at the Hajj House office in Abuja.

Professor Usman described the relationship between the two pilgrimage commissions as harmonious, referencing the peaceful coexistence exemplified by Prophet Muhammad (SAW) with Christians in Madinah.

He lauded the symbolic meeting of the two religious leaders and promised to reciprocate the visit soon. He emphasized that sustained cooperation and goodwill between the two commissions would help unite followers of both faiths. He reiterated that there should be no room for discord between Muslims and Christians and commended President Bola Ahmed Tinubu for his continued support of both NAHCON and NCPC.

Bishop Adegbite, in his remarks, called for stronger collaboration between NAHCON and NCPC, encouraging frequent engagements between the two commissions.

While congratulating Professor Usman on his appointment, Bishop Adegbite revealed that February 5 marked his first year in office. The Commissioner of Operations, Inspectorate and Licensing Service (OIL), Prince Anofiu Olarewaju Elegushi commended Bishop Adegbite as a brother who fosters religious unity, recalling that their relationship dates back to their time in Lagos when Prince Elegushi was Commissioner of Home Affairs.

NAHCON remains committed to ensuring that Nigerian pilgrims perform Hajj with ease, dignity, and at an affordable cost. Additionally, the Commission will continue to promote religious harmony and cooperation, recognizing the importance of unity in national development.

## FCT: Mallam Kadiri Edah unveils first phase of Hajj orientation for intending pilgrims

THE Federal Capital Territory (FCT) Muslim Pilgrims Welfare Board in Abuja has begun the first phase of its education and orientation exercise for intending pilgrims for this year's Hajj.

The Director of the Board, Mallam Kadiri Edah, disclosed this in an interview with newsmen in Abuja. He stated that the orientation exercise commenced on Saturday, February 8, and Sunday, February 9, 2025, at the FCT Permanent Hajj Camp located at Basan Jiwa, near the Nnamdi Azikwe International Airport, Abuja.

According to the Director, Islamic scholars have already been mobilized for the exercise to prepare the intending pilgrims for an acceptable Hajj. Mallam Edah explained that the exercise would be conducted in phases, as usual, to enlighten the intending pilgrims on the Hajj rites and the new policies introduced for this year's Hajj by the Saudi authorities and the National Hajj Commission of Nigeria (NAHCON).

He noted that the Board has already mapped out strategies to educate the intending pilgrims on the exercise, especially since new policies were introduced by the Saudi Arabian government this year, which are specific to pilgrims.

He advised intending pilgrims from the Territory to participate in all programs organized by the Board to assist them in achieving an acceptable Hajj. He also urged intending pilgrims, particularly first-timers, to take advantage of the exercise to enhance their Islamic knowledge on Hajj rites and receive proper guidance, ensuring they get value for their money and fulfill their religious obligations.

The Director warned all intending pilgrims who have yet to return their completed application forms or submit their international passports to do so immediately, enabling the Board to commence the process of their travel documents.

He stated that only intending pilgrims who complete the Hajj fare of N8,457,685.59 (Eight Million, four hundred and fifty-seven thousand, six hundred and eighty-five Naira and fifty kobo) and above would be shortlisted for this year's Hajj, following the expiration of the registration deadline set by the National Hajj Commission of Nigeria (NAHCON).

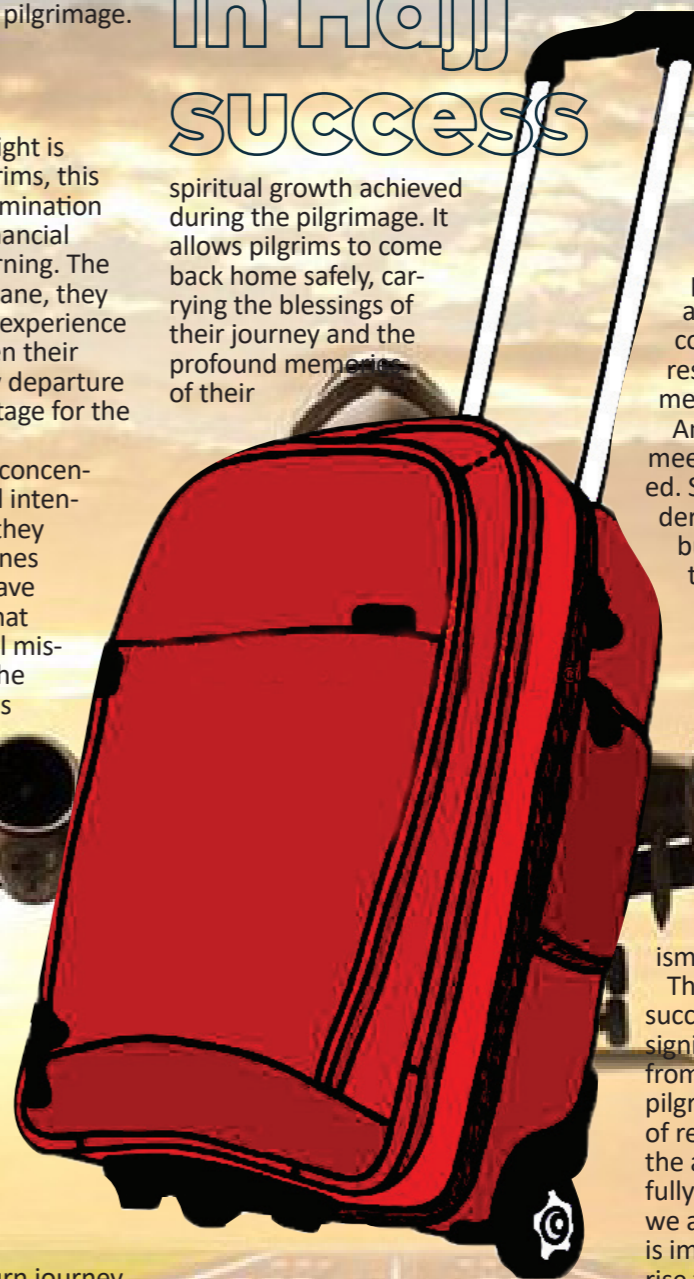

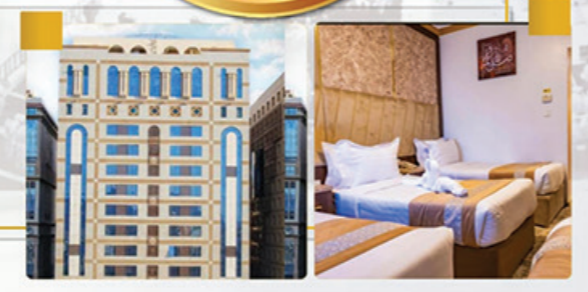

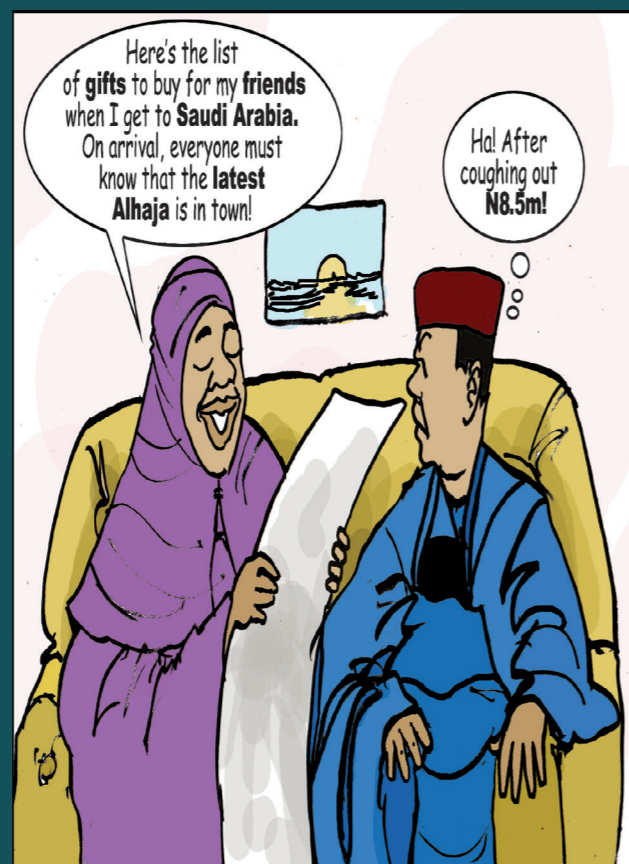

## SHARIAH PANEL IN SOUTH-WEST: A battle for identity, self-determination amid raging controversy

•Muslims can't live life outside sharia — Sharia judge  
•Govt failed has failed Muslims, says Legal practitioner  
•As Non-Muslims react

**A** contentions debate has erupted in South West Nigeria over the establishment of Shariah panels in the region, with Muslim leaders emphasizing their right to self-determination and non-Muslim groups expressing apprehensions about the potential implications of such panels.

At the heart of the controversy is the distinction between Shariah courts and Shariah panels. However, Muslim leaders

have maintained that the proposed Shariah panels are not courts but rather arbitration committees that will handle civil matters such as marriage, divorce, inheritance, and disputes over contractual agreements between Muslims.

In a bid to explore the intricate dynamics surrounding the establishment of Shariah panels in South West Nigeria, Ishola Balogun engaged with both Muslim stakeholders and non-Muslims to gather a diverse range of perspectives

on the matter. As discussions intensify regarding the role of Shariah in the region's legal framework, opinions vary widely. Supporters advocate for the establishment of Shariah courts as a means of recognizing and accommodating the unique legal needs of the Muslim community, while critics express concerns about potential implications for broader societal cohesion. This engagement aims to illuminate the complexities of the ongoing debate, highlighting the hopes, fears, and historical contexts that shape the views of both communities.

A legal practitioner who is also a Sharia judge (Qadi) at the Sharia Panel in Lagos State, Mr. Trimizee Adisa Dairo, said the quest for Shariah panels is about asserting their right to live according to their faith. "Shariah is part and parcel of a Muslim's life," Dairo emphasizes. "It encompasses our private and public life, social and economic life. Our lives are regulated by Shariah."

"Shariah is part and parcel of a Muslim's life, and no Muslim will deny that. Again, Sharia is wide and comprehensive. It encompasses our private and public life, social and economic life. Our lives are regulated by Sharia. Therefore, it is impossible for a Muslim to live without Sharia. Once you take away Sharia

from the life of a Muslim, he becomes a non-Muslim. That is how important it is. It is not like other religions that regulate their practices on a matter of faith. That is why Sharia is very important to a Muslim and in a Muslim's life."

Difference Between Shariah Panel and Shariah Court

"There is agitation by Muslims in the Southwest to allow the application of Sharia so that Muslim marriages will be governed by Sharia as opposed to Yoruba customary law, Muslim inheritance will be governed by Sharia as opposed to customary law, and the guardianship of children will be regulated by Shariah law.

"These are permissible, and these are what is going on in the North. It is the right of Muslims in the South West to be governed by the law of their religion regarding those highlighted matters. Since the constitution expressly provides for this, it is a genuine agitation that has been ongoing for some time. That is as far as the official courts are concerned because it is the business of the government to establish courts to govern people in the state."

"Also note that none of the states in the South West has acceded to that; they have all rejected it, apparently because of criticisms and opposition from non-Muslims. But on the issue of having a panel, it is different. It is like arbitration, and the law of arbitration is very clear. A Muslim can decide to contract his marriage under Sharia and within the fold of Islam, and when this is done, he has the fundamental right to seek redress on the same issue under an arbitration panel. That does not require any form of state approval because it falls under the freedom of association to submit willingly to arbitration proceedings. If both parties submit to the arbitration proceedings, then the decision becomes binding on them. It is not for Christians and non-Muslims alike to begin to cry out about why Muslims want to have an arbitration panel; it shows they are ignorant of the issue they are criticizing.

"For a Christian who has issues in his marriage, he has a place to go, which



is the High Court. For those who willingly decide that they want to be bound by the customs and traditions of the Yorubas, if they have issues in their marriage and inheritance, they go to the Customary Court, and the customs will be upheld there. For Muslims who do not consent to either of the two, where do you expect them to go when they have issues? We have seen situations where Muslims go to the Customary Court on issues of marriage, and the court says it has no jurisdiction to entertain the matter because the marriage is governed by Muslim law, not customary law.

"Remember that the government

has failed to create a court that will look into such matters. So, in order to fill the gap and circumvent that problem, Muslims have come together to establish arbitration panels. That is exactly what Muslims are doing all over the South West. It is the failure of the government to do the needful. Our government officials attend Muslim marriages, but they fail to understand that the couple has no place to turn to when issues arise in their marriage. This is where the Sharia panel comes in.

### Addressing Misconceptions

"I think non-Muslims only focus on one aspect of Sharia, which is the criminal aspect. One of the public laws in Sharia is the non-criminal aspect. Just as Sharia is a system of law, people are always apprehensive about any law; they become apprehensive about the punishments. They hear about stoning to death, cutting off hands, and so on, but Sharia is not limited to that, and it is rarely possible because its execution is the duty of the state, not individuals. Besides, it is optional if you choose to be bound by that.

"So, I don't know why non-Muslims should entertain any fear. Nigeria is ruled by a constitution, and we can have two systems of law running concurrently; Sharia is allowed with very limited application as it relates to Muslim private life. That is why the constitution allows Muslims to be governed by Sharia in the aspects of marriage, divorce, inheritance, guardianship of children, and to some extent, in any contractual agreement. These are the areas, so

outside these areas of law, Sharia is not applicable, at least at the official level in Nigeria. So, non-Muslims are only being apprehensive without any basis.

### Stressing the Need for Sharia Panels

Responding to how Muslims were resolving marriage disputes before the advent of Sharia panels, he noted, "If those disputes had been resolved by the conventional court, it means they didn't take cognizance of the fact that they were contracted ab initio under Islamic law, and moreover, because there was a dearth of experts in Islamic law. It is not as simple as that. Muslim marriages are not the same as Christian or customary marriages. Yes, you can rightly assume that Christian marriages are statutory marriages. That is why when there are issues, they go to the conventional courts. As for Muslims, they cannot go to the conventional courts because Muslim marriages are Islamic in nature and regulated by Sharia. That is why I said earlier that Sharia governs the private and public lives of Muslims. These benefits are enjoyed by our northern brothers because they go to the Sharia courts on such issues. It should also be noted that these Sharia courts do not entertain complaints from non-Muslims.

"I don't know the reason for the ap-

pre-hension because it is strictly for Muslims and not for non-Muslims. You will

not hear of a Sharia court in the North assuming jurisdiction over a Christian or someone whose marriage was not contracted according to Sharia. That is what we are clamoring for here. The agitation is simple: to adju-

allows. These are areas of marriages, divorce, inheritance, guardianship and to some extent, contract. It's constitutional provision.

### Between Litigation and Arbitration — Barr Olarinde

An Ibadan-based legal practitioner, Barr Marthina Olarinde, said, "I don't think we are ready for that. It is a structure that is very rigid, and there is no escaping it. Once a judgment is pronounced, it is difficult to overturn. This is about religion, and you don't play around with it. Once it is declared to be A, they go for A. Whatever justification anyone provides will not change that. As long as it is related to religion, it is inflexible. It is strict, and I believe we are not prepared for that.

"However, having said that, as long as anyone chooses to be bound by it, it shouldn't pose any issues. The fact is that it is optional. It is up to the individual to decide whether to pursue litigation or arbitration," she said.

### CAN leader declines comment

The CAN Chairman, YEWA South, Ogun State, Catchiest John Akapo declined comment saying: "I don't know anything about the agitation of sharia panel and I can't comment on that.

### Panel can't compel people to submit to arbitration

Mr. Shakirullahi Obale, another sharia judge at the Abesan Sharia arbitration panel, offers a deeper perspective. "The Sharia Panels we are asking for in the South West cannot compel people to submit to its arbitration. It is a misconception—and indeed a sign of narrow-mindedness—to believe that Islamic Sharia is solely about killing, stoning, amputation, and similar punishments.

"Today, we have Jaiz Bank and other Islamic alternative financial institutions,

discate Muslim marriages, guardianship of children, and inheritances."

### On possible spread of Shariah in the region

"It is not possible unless it is codified or passed into law by the state House of Assembly. In criminal law, you don't commit an offence unless that offence is expressly written as a law. The criminal aspect has not been approved or codified by the state, so, there is no way the sharia court will do that. There are aspects of the Sharia the constitution

including Sukuk bonds and others. Are the operations of these Islamic-based organizations and policies about killings? No, they are not. However, there are ill motives to distort the perception of Islam.

“There is a difference between Sharia panels and courts. A Sharia panel is solely for arbitration. As one of the judges (Qadi), we have two panels in Lagos State—one in 1004, Lagos, and the other at Abesan Estate. Unlike the courts, which are established by state law, a Sharia panel cannot compel people to submit to its arbitration. No individual or organization can establish a Sharia Court of Appeal. Those who criticize it and those who threaten legal action are raising issues without any basis.

“Sharia, as we know it, has been in existence in Nigeria since 1908. Some people are determined to castigate anything related to Islam. The Sharia panels operate in mosques to settle issues regarding marriage, inheritance, divorce, guardianship, and contracts. Therefore, there is no basis for criticism. Some of those who criticized Jaiz Bank and Sukuk in the past are now benefiting from them. They may lack knowledge about their operations, but they find it convenient to criticize. As it stands, Islamic law is recognized by the constitution.”

## Govt failed has failed the Muslims

He explains further: “Muslims in the South West are agitating because it is their right. The constitution expressly provides that a Sharia Court of Appeal can be established by any state, provided it is passed into law by the state House of Assembly. This agitation has been present, yet none of the states in the region has acceded to the demand. Several proposals have been made, but they have been rejected, apparently because of criticism from non-Muslims. “As for the establishment of a panel,

it is intended for arbitration. The law of arbitration is very clear: it serves as a means of mediation to resolve disputes. In that regard, Muslims can choose to participate or not in matters related to marriage, divorce, and other issues mentioned earlier. This does not require any form of state approval; it is about the freedom of association. This situation arises because the government has failed in its duty to do the right thing. No Muslim can live a life outside the Sharia. It is not possible.”

Despite all the criticisms, Obale expressed optimism that the agitation will come to pass sooner.

“Yes, I hope so, and Insha Allah, it will happen. Whether they like it or not, we will have a Sharia Court of Appeal. I am surprised that Lagos State has not initiated this because it is known as a leading state in many aspects. The administration of criminal justice was started by Lagos State. One day, we will have this in one of the states,” he said.

## We're not afraid of legal action, MURIC talks tough

As the issue rages on, the Muslim Rights Concern (MURIC) has also weighed in on the controversy, with its Executive Director, Professor Ishaq Akintola, asserting that Yoruba Muslims are not afraid of legal action. Akintola pointed out that Shariah panels already exist in several states in the South West, including Lagos, Ogun, and Osun, and that they operate within the framework of the Nigerian constitution.

Akintola criticized the Yoruba Council's opposition to the Shariah panels, describing it as an attempt to create tension. “What is the big deal? Why so much fuss? Isn't this much ado about nothing?” he asked. The MURIC director also invoked historical instances of Shariah courts in the region, noting that they have been a part of Yoruba Muslim tradition for centuries.

He also addressed incorrect accusations against the Shari'ah panels, clarifying that they do not impose laws

on non-Muslims and that participation is voluntary. “Only those who want to make caricatures of themselves will think of stopping the Shari'ah panels. They are not disturbing anybody,” he stated. Akintola took issue with the Yoruba group's letter, noting it was addressed to the wrong individual, and emphasized that their claims about Shari'ah lacking history in Yorubaland were unfounded.

## Historical perspective to Shariah

The Supreme Council for Shari'ah in Nigeria (SCSN), a legally registered entity, has been at the forefront of this struggle.

According to the SCSN, Shariah law is not just a moral code, but a complete system of law that governs all aspects of a Muslim's life. The group argues that the Lagos State government's failure to establish Shariah courts has led to the marginalization of Muslims in the state. Currently, only Common Law and Customary Law are recognized in the state, leaving Muslims without a legal framework that aligns with their faith.

The SCSN points to the 1999 Constitution, which recognizes Shariah law as one of the three legal systems in Nigeria. The group argues that the Lagos State government's refusal to establish Shariah courts is a violation of Muslims' constitutional rights. The SCSN has been working tirelessly to establish Shariah panels in the state, which have been operating since 2002. These panels have received widespread acceptance from Muslim Lagosians and have published select judgments in a law report.

Despite the progress made, the SCSN faces opposition from some quarters, including the Yoruba Council Worldwide, which has threatened legal action against the group. However, the SCSN remains undeterred, arguing that the demand for Shariah courts is not a new phenomenon, but a century-long struggle for recognition and justice.

The group's efforts have been bolstered by court judgments, including a 2008 Lagos High Court ruling that Shariah law is not the same as Customary Law. The SCSN is confident that its demand for Shariah courts will ultimately prevail, citing the constitutional provisions that recognize Shariah law as a legitimate legal system in Nigeria.

## NAHCON under Prof Usman will not overcharge pilgrims with unrealistic Hajj Fare

As activities ahead of Hajj 2025 take full swing, the National Hajj Commission of Nigeria (NAHCON) is deploying necessary measures to ensure a hitch-free and rewarding spiritual exercise for Nigerian pilgrims. For obvious reasons, the Hajj exercise in the country comes with peculiar concerns on a yearly basis. It is little wonder that NAHCON receives maximum national attention during this time.

Nevertheless, it is imperative for the Nigerian Hajj Media Support, a concerned group monitoring and reporting on Hajj affairs as they relate to Nigerian pilgrims, to express deep satisfaction with the level of preparations put in place so far by NAHCON.

Just recently, the group witnessed the conclusion of a pre-Hajj visit by all stakeholders in the industry to Saudi Arabia, where NAHCON, on behalf of Nigeria, signed a Memorandum of Understanding (MoU) with various service providers that will render premium accommodations, transportation, feeding, and other necessary welfare services to Nigerians in Saudi Arabia.

The group also vividly recalls the successful conclusion of the selection of air carriers that will convey Nigerian contingents to the holy land. Four airlines, including one Saudi-based airline, passed the due diligence process.

Similarly, the Commission released the much-awaited final fare for the 2025 Hajj to the public. The fare for this year's pilgrimage came with ease and alleviated the tension of possible outrageous costs that many unpatriotic elements had patiently awaited.

However, NAHCON, under the diligent chairmanship of Professor Abdullahi Usman Pakistan, released the unexpected. Accord-

ing to the template, pilgrims from the Adamawa and Maiduguri zones will pay N8,327,125.59, those from other northern regions will pay N8,457,685.59, while their counterparts from the southern region are expected to remit N8,784,085.59.

Of course, those who are familiar with what determines the differential in the fare know that it wasn't intentional to force pilgrims from one region to pay more or less than their counterparts from other zones; the costing is purely based on the nautical miles between designated destinations and the holy land.

No doubt, the final fare for the 2025 Hajj reflects a slight variance of less than 4 percent increase compared to what pilgrims paid in 2024. Even with the Federal Government subsidy that could not be explained, the present management of NAHCON, under Professor Abdullahi Usman Pakistan, has surprised speculators

for who were waiting a N10 million announcement.

Even though much less was expected, the group considers the fact that Hajj fare is predominantly dollar-based, and Nigerian pilgrims are being charged



based on the market rate of the naira and its equivalent in exchange to the US dollar.

Incidentally, the NAHCON Chairman, Professor Abdullahi Usman Pakistan, clarified the use of N1,600 as a benchmark to determine the Hajj fare. While defending NAHCON's budget for 2025 before the National Assembly on Tuesday, Professor Pakistan justified the commission's decision to peg N1,600 as a baseline, essential to avoid the volatility of the exchange rate.

The Nigerian Hajj Media Support monitored how the volatility of the exchange rate of the naira to the US dollar almost disrupted previous Hajj exercises. Notably, pilgrims were forced to incur extra charges amounting to millions of naira just to cover the gap created by the sudden crash of the naira.

The Nigerian Hajj Media Support, therefore, wishes to reaffirm confidence that NAHCON, under the able leadership of Professor Abdullahi Usman Pakistan, has taken bold steps and preventive measures against any eventuality that may further escalate the Hajj fare.

Recall that upon assuming the hot seat at the Hajj house, Professor Pakistan pledged to operate under accountability and transparency. We don't expect anything less from a man of proven integrity.

In any case, the group is confident that NAHCON, under Professor Pakistan, will not hesitate to announce any surplus from what was charged and will even facilitate a refund of such balance to pilgrims when necessary.

However, the group is aware of the evil hunters within and around the commission, under any disguise, who may be plotting the downfall of the present management. We can only encourage them to continue chasing shadows. Those raising false alarms have ample time to watch the activities of NAHCON and raise necessary criticism at this point.

NAHCON, under Professor Pakistan, will not be distracted by the antics of unscrupulous elements but will rather focus on the task at hand to make this year's Hajj better than previous experiences.

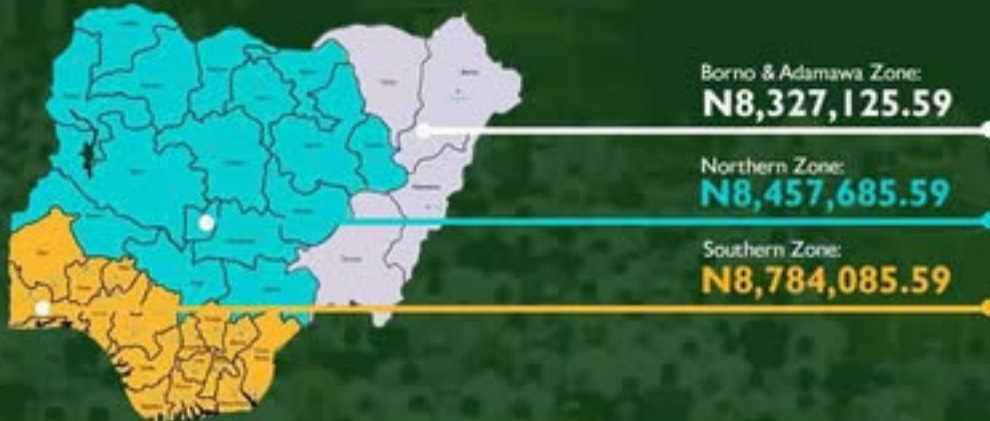
